All change at Head Office

Stephen has made a number of changes within the Senior Management Team at Head Office to ensure that we have effective lines of communication and accountability within the team. This is particularly relevant during a period of change to ensure that the team is fit for purpose, responsive and capable of responding to an ever-changing landscape.

In summary, the new structure includes the following changes:

- There is a new Executive Management Team reporting into the Chief Executive, thus reducing the number of direct reports into the Chief Executive, with the intention of strengthening and streamlining the strategic decision-making process within LIFE. This team replaces the Senior Management Team.
- Margaret Coward has been appointed to the new position of Director of Operations. This post will bring together the three main service functions of Care, Housing and Retail to enable a more co-ordinated service delivery to our customers and service users. Eireann Janssens and Liz Lloyd will continue in their roles reporting to the newly created Director of Operations.
- David Bennett has moved to the new post of Director of Development and Communications, bringing together the business critical roles of fundraising, communication and campaigns into one department. Stuart Cowie will continue as Communications Manager reporting into the newly created Director of Fundraising and Communications.
- Elly Petrucci has taken on the new role of Strategic Projects Manager, created to respond quickly to and deliver on strategic priorities and projects as assigned by the Chief Executive.
- Isaac Nyirenda will continue in his role with a new title of Director of Corporate Services and Finance.
- Anne Scanlan will continue in her role with a new title of Director of Education and Media.
- The posts of Head of Housing, Head of Fundraising, National Development Manager and Head of Communications have been removed.

Brompton Oratory (London) – the start of a new LIFE group


David Bennett and Michaela Aston were kindly invited by Fr Edward and the Friends of Brompton Oratory to give a presentation to an invited group on the vital work of

LIFE National Helpline – a day out to Sheffield



Stephen and I spent a delightful day in Sheffield with the National Helpline volunteers. The team updated Stephen on their vital role at the frontline of our work with crisis pregnancies. The volunteers got to know Stephen over lunch, which was followed by CPD training delivered by our National Care Manager, Liz. All had a good day, even if Stephen was an hour late!

VAT reclaims for shops (oh the excitement!)

OK...a delicate subject! In my first 10 weeks, there has been a reoccurring tension relating to the transfer of monies from group accounts to shop accounts and vice versa. Thomas Gower has written to you about this recently as part of a finance team exercise in reporting separately on group and shop expenditure.

So, why are we doing this? We are attempting to register for VAT to enable LIFE as a charity to reclaim VAT. This is more money in the pot. Now...this is particularly relevant to our shops and if we are successful we will be able to reclaim some backdated VAT of up to circa £40k and a further annual amount. You can see why we are interested in pursuing this option and why it is important for us to get a realistic picture of what shop income is.

Email is not always a great way to communicate and particularly over such a sensitive issue as how shop and care centre expenditures should be apportioned. I will be looking into this more closely over the coming months. As you will have already read, over the next six months, I am completing a root and branch review of how the charity operates and this will include the shops and care centres. I am told that there has always been an understanding that shops would pay for the basic running costs of the care centres attached to them.

The local LIFE groups are the heart and soul of the organisation. Over the coming year we will be exploring in particular how we can provide you with more support and, in particular, to recruit new younger group members...we know what a challenge this is. This will, of course, include some changes in how we operate to ensure that we have a sustainable future and, where possible, we decentralize activities and services to a local level.

I hope that you are able to bear with me over the coming period as we find a way forward together for LIFE and the vital work it does in transforming and saving the lives of so many people that we encounter. I will continue to visit groups and consult on how best to reshape LIFE for the next 40+ years.

Please do keep in contact with me over the next six months and I would be delighted to meet with your group if you would like. I much prefer to talk with you face-to-face to share ideas about the future. E-mails are not so good for this!
